#### **Political Education Chair Message**

At the end of 2023, the big news to close the year is that the Irish Government <u>is taking an</u> <u>inter-state case against the UK government</u> over its controversial Legacy and Reconciliation Bill. The Government's case is based on the belief provisions of the Bill are incompatible with the European Convention on Human Rights (ECHR), of which the UK is a signatory. President Biden gave <u>Dublin's rare legal challenge his personal blessing</u> when he met with Leo Varadkar. Mr Biden, proud of his Irish roots, offered Mr Varadkar his support in the case and the effective green light in New York in September. Not surprisingly, <u>the UK government "profoundly regrets"</u> the move to legally challenge its legislation. In a statement, Britain's secretary of state for Northern Ireland slammed the case as "unnecessary" and warned it came at a "particularly sensitive time in Northern Ireland". "It did not need to be taken now, given the issues are already before the UK courts," Mr Heaton-Harris said, referring to a legal challenge that was heard in the Belfast High Court. A judgement there is awaited.

The legal process will take a couple of years to come to a judgment. It is an election year in Britain. The case will likely land on the desk of a new British Prime minister. The Labour leader and bookies' favorite to win, has <u>said that he will revoke the legislation</u>.

Some commentary / context

Sometimes it is hard to convey, in an even-handed way, how lawless the passage of the Legacy and Reconciliation Act was. To this end I share a different, contemporary example regarding immigration.

Like the US, England would prefer immigrants were processed outside the country, then allowed in when they had proper documents. In April 2022, Britain signed a deal under which some asylum seekers who arrive in the UK across the English Channel were to be <u>sent to Rwanda</u>, where their asylum claims would be processed. The UK Supreme Court concluded that the UK is party to various conventions, including the refugee convention, which would dictate that the Rwanda plan is unlawful.

Rishi Sunak began preparing law that <u>would defy ECHR (European Convention on Human</u> <u>Rights) over Rwanda asylum deportation plans</u>. However, this month, a senior Minister who was to introduce the new Bill on Immigration resigned because he believed that the Sunak bill <u>did not go far enough</u>, because the proposed bill was still bound by the ECHR. PS: <u>The bill passed</u> on 12-Dec on a 313 to 269 margin.

<u>As Sein Fein noted</u>, this behavior is not only restricted to immigration. Early in the Brexit process, a British Minister stood up in Westminster to declare that new Brexit legislation would only break international law "*in a limited way*". Just imagine trying that defense to a cop: "Yes, I do intend to break that speed limit, but I have the right to do so in a limited way."

So, for people to think that the passage of the Legacy Bill was a 1-off act of lawlessness done in deference to veterans (?), you should know it is a pattern of doing what is expedient rather than what is right, and worrying more about domestic politics vs international commitments you agreed to.

#### **Financial Secretary Notes January 2024**

Happy New Year! This month I want to summarize a conversation I had with AOH National Secretary, Ray Lynch.

But first I want to say I'm happy to say we only had to suspend seven members, not counting associate members, for non-payment at the end of 2023. That did result in us ending the year with less than 300 (294) but it was the fewest such suspensions in a long time and we'll be over 300 soon. I'm also happy to note that over 65% of our members have already paid their 2024 dues.

#### Discussion with National Secretary.

Each year, nationwide, the AOH tends to suspend over 1,000 members at year end for non-payment. When the AOH goes to representatives in congress, etc. they ask for membership data and seeing 1,000 lost members each year does not look good. To reduce that number division financial secretaries were required to call Secretary Ray Lynch to discuss why members were being suspended at year end, what steps were taken to avoid that action, what actions are needed to try to bring those members back, and, to have that conversation prior to the new, earlier last action date of December 20. The earlier year end date will also help expedite issuance of 2024 membership cards. He was very pleased with the retention efforts we have put in place (financial

incentives and penalties related to dues, multiple email and postal notifications, key card suspensions, the policy notice in the monthly newsletter, and the fact that the newsletter is distributed four ways (mail, email, in club, and on website).

Ray noted that the national roster tool is being updated again soon. That update will allow for a non-payment status so that National can choose to keep those members on the National roster if they so choose without charging the Division the per Capita. It also will allow for reinstated members to come back under their prior member number which the current system does not do and thereby makes it look like more members have permanently left the AOH than is true. This will make the voice of the AOH stronger.

To try to bring back members, each Division is expected to assign two members the task of contacting any members suspended for non-payment and trying to bring them back into the organization.

Also, he noted that we should present the full list of unpaid members as of September 1<sup>st</sup> at our September meeting so we a) have wider circulation of the list to help reach out to unpaid members, and, b) to formally vote for approval of the suspensions if needed, in December.

**Closing Note:** We will be having an initiation ceremony during our February meeting and we may bring in over 15 new members!

#### January in Irish History

The Act of Union (1801): On January 1, 1801, The Act of Union between Ireland and Great Britain went into effect uniting the Kingdom of Great Britain and the Kingdom of Ireland to create the United Kingdom of Great Britain and Ireland. Before the Act of Union, Ireland had been in personal union with England since 1542, when the Irish Parliament passed the Crown of Ireland Act 1542, proclaiming King Henry VIII of England to be King of Ireland. The union saw the dissolution of the sectarian, puppet Irish parliament in Dublin where only members of the Church of Ireland (Anglican) were allowed to be members of parliament. Thus, excluding the majority Catholic population as well as non-Anglican Protestants.

Many wealthy Catholics, who were allowed to vote, were in favor of the Act of Union as they believed this would lead to religious emancipation and the resulting right to become a member of parliament.

The British establishment was in favor of the act as they were in fear of the influence of the American and French Revolutions on Ireland and in the aftermath of the rebellion of 1798 they wanted to ensure stronger control over the country.

The Repeal Association to repeal the Act of Union was set up in 1830 by Daniel O'Connell who was elected the first Catholic to the British Parliament since 1688, in 1828.

The Birth of Douglas Hyde (1860): Douglas Hyde was born January 17, 1860, in Castlerea, Roscommon, the son of a Church of Ireland minister. Hyde grew up at a time when the Irish language was still spoken in that part of Roscommon. As a teenager, he began to study the Irish language and folklore before becoming an academic at Trinity College Dublin. Hyde was a founding member and first president of Conradh na Gaeilge/Gaelic League, an organization to promote the Irish language and culture in the belief that an independent Ireland could only exist if it had its own language and traditions. In 1938 Douglas Hyde became the first President of Ireland under the new 1937 constitution.

**Irish War of Independence (1919)**: Two members of the Royal Irish Constabulary (RIC) escorting a consignment of gelignite explosives were shot dead on January 21, 1919, by IRA Volunteers including Seán Treacy and Dan Breen in an ambush at Soloheadbeg, Co. Tipperary. The IRA Volunteers were acting on their own initiative. The Soloheadbeg Ambush is regarded as the start of the 'War of Independence' (Anglo-Irish War) as the ambush happened on the same day the First Dáil (the independent Irish Parliament) met and declared Ireland's independence.
